NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

1. NAME OF THE TRUST

The name of the Trust shall be "SATYANARAYAN EDUCATIONAL TRUST".

2. OFFICE OF THE TRUST

The Office of the Trust shall be situated at Mittanchak, Sadallichak, Patna 804453, or at such other place in India as the Trustees may from time to time think fit.

3. OBJECTS OF THE TRUST

The objects of the Trust shall be any or all of the following:

- i. Advancement and propagation of education and learning including establishment, maintenance, and support of school and other educational institutions.
- ii. To make provision to advance the cause of, and impart Primary, Secondary, Higher, Commercial, Industrial, Technical, Physical and all or any other type or kind of education.
- iii. To establish, maintain, take over management, administer, or run any institutions, colleges engaged in the imparting of education to students up to any level that may be found necessary and/or desirable.
- iv. To generally impart education to children and for the purpose to do all acts that may be necessary or incidental thereto.

- v. To hold, arrange and organize meetings, lectures, talks, discussions, seminars, symposia, conferences, competitions, and study visits, tours, excursions, exhibitions, debates, cinema, audio-visual programs, the artistic performances and other cultural activities, sports and games.

- ix. To do all acts that may be necessary and incidental to the attainment of the above objects.

- (f) The Maximum number of Trustees including the Chairperson and the Managing Trustee shall not exceed nine at any given time.

- (g) In case of any vacancy amongst the Trustees occasioned by death, resignation or incapacity of any Trustee, the remaining Trustees with the consent of the Chairperson shall co-opt any person or persons who may be helpful in achieving the objects of the Trust as a Trustee.
- (h) A Trustee shall cease to hold Office of Trust on the Trustee becoming insane.

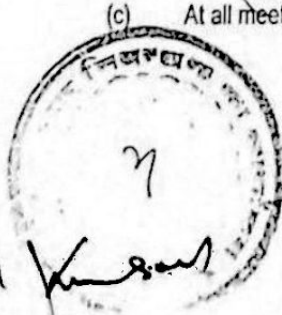
3. MANAGEMENT

- (a) It will be the overall responsibility of the Chairperson to ensure adherence to the objects of the Trust and implementation of the decisions taken at the meetings of the Trust.
- (b) The Managing Trustee shall be responsible in general, for the day to day affairs of the Trust and for implementing the decisions taken at the meetings of the Trust as per the directions of the Chairperson.
- (a) The management, control of the properties and affairs of the Trust aforesaid shall be vested in the Trustees with full power. It shall be lawful for the Trustees from time to time to frame such rules and regulations for the management and administration of the Trust and charities as they deem fit and to alter or vary the same from time to time to make new rules and regulations provided such rules and regulations shall in no way be inconsistent with the objects, terms and intents of these presents.
- (b) The Trustees shall meet as often as possible but not less than two times in a year for efficient management of the Trust, to consider the income and expenditure and for disposing of all such other matters as may be raised in such meetings or might have arisen in the interregnum.
- (c) At all meetings of the Trustees, two trustees will form the quorum.

- (d) At all meetings of Trustees, the Chairperson or in his absence any other Trustee elected by the Trustees present shall be the Chairperson of the meeting and all decisions of the Trustees shall be by majority vote so however that the Chairperson shall have a casting vote in case of equality of votes.
- (e) All proceedings of the meeting of the Trustees shall be recorded by the Managing Trustee in a Minutes Book kept for the purpose.

4. POWER AND DUTIES OF TRUSTEES:

- (a) The Trustees under these presents shall have the power to manage Trust Funds, collect and recover income of any kind accruing legally to the Trust and to pay thereout the expenses of collection and other outgoings.
- (b) The Trustees shall have all powers to do such things as may be required for the proper conduct of the Trust and in the interest of the Trust.
- (c) The Trustees shall be entitled from time to time to open, maintain, and operate Bank Accounts in the name of the Trust or in the name of Trust-run Training Centres, Schools or Institutions with such Scheduled Bank or Banks as they may from time to time decide. Any such account may be operated either individually by the Chairperson or jointly by the Managing Trustee and any one of the other Trustees.
- (d) The Trustees shall have power to maintain and defend all such suits and take such other steps as may be reasonable and requisite for the preservation of Trust Properties and the protection of the title thereof. The Managing Trustee, or such other person authorised by the Trustees in their meeting and confirmed by the Chairperson in writing, shall represent the Trust in such proceedings.



- (e) The Trustees are bound by all the liabilities cast upon them under the Indian Trusts Act of 1882 in addition to the powers specifically conferred under these presents.
- (f) The Trustees at their discretion may purchase or otherwise acquire movable and/or immovable property or properties as may be deemed necessary by the Trustees for attainment and achievement of the objects of the Trust.
- (g) The Trustees at their discretion may sell any movable and or immovable property or properties which may for the time being be the subject of the Trust of these presents, with power to buy and sell the same without being responsible for any loss that may thereby be incurred and in case of such sale, to execute and do all such deeds and acts for the purpose of carrying such sales into effect as the Trustees may think necessary and all monies accruing from any such sale shall be deemed to be part of the Trust Property and shall be applied accordingly.
- (h) The Trustees shall have the power to run and manage any institution for advancing the objects of the Trust and for that purpose do all acts necessary or incidental thereto such as appointment of staff, acquisition of or taking on lease appropriate building or buildings or other physical space.
- (i) The Trustees may at any time receive voluntary contributions from any person, persons or institutions by way of donation, legacy, and gift, annual or monthly subscription for the benefit of the Trust. The Trustees shall apply such contribution strictly in accordance with the objects of the Trust.
- (j) Proper accounts showing all receipts and disbursements made on account of the Trust hereby constituted shall be kept by the Managing Trustee on behalf of the Trustees. The Managing Trustee shall also

cause to be prepared Receipts and Payments Account, Income and Expenditure Account for each year or part of the year ending on March 31 each year and Balance Sheet as on that date which shall be duly audited by a qualified Chartered Accountant.

5. DISSOLUTION

In the event of dissolution or winding up of the Trust the assets remaining on dissolution/winding-up shall be transferred to another Trust, Society or Institution whose objects are similar to those of this Trust and in no event shall the assets so remaining be distributed among the Trustees.

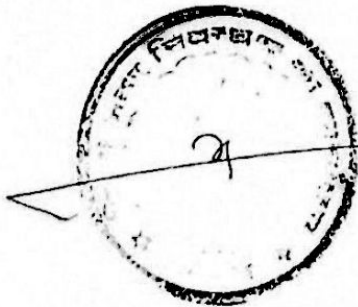

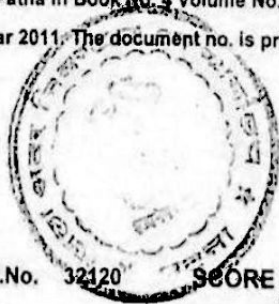
